What do I do if I have been exposed to COVID-19?

- Seek medical attention, resources offered by the University:
 - Campus Health offers services to students
 - For employees, the Environment, Health and Safety (EHS) and Employee Occupational Health (UEOHC) provides contact tracing and medical services
- If you need to be tested, you will need to quarantine while waiting for results
 - Please discuss an alternative work plan with your manager/ supervisor
 - Your manager/ supervisor will not disclose any identifying details
- If you test positive, you will need to take time off to rest and recover. You must be cleared by your healthcare provider before returning to work/ campus.

If I need to take a leave, how will it affect my pay?

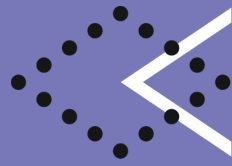
- Here is UNC's Division of Human Resources and Equal Opportunity and Compliance policy, effective August 1, 2020
 - If an employee is unable to work due to (1) being subject to a quarantine/isolation order, (2) being advised to self-quarantine, or (3) experiencing COVID-19 symptoms, and the employee has exhausted their FFCRA leave benefits, accrued leave, and accrued paid time off (comp time, etc.). In those limited circumstances, employees who have exhausted all accrued leave will receive COVID-19 paid administrative leave at 100% of their pay, cumulative up to 160 hours through Dec. 31, 2020.

Will individuals with COVID-19 be identified?

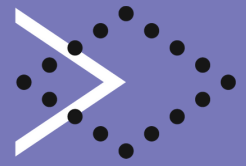
- No. It is against the law to disclose of your health information.
